

2nd Fix Redemption Promotion 2025 TERMS & CONDITIONS

1. Claim Process and Eligibility

- 1.1. Paslode UK ("Paslode"), is offering a free Paslode Battery and Merch Pack with specifications: paslodeuknordics.ac-page.com/Trim-Redemption-Offer-Sep2025 (the "Battery and Merch Pack") to certain end-user purchasers of the IM65 or IM65A Finishing Nailer.
- 1.2. To be eligible to claim a Battery and Merch Pack, participants must purchase an IM65 or IM65A Finishing Nailer (the "Qualifying Products") between 08.09.2025 and 30.09.2025 from an approved Paslode UK dealer (a "Qualifying Retailer").
- 1.3. Participants must submit their claim to Paslode by 23:59:59 on 22.10.2025 (the "Claim Deadline") in accordance with these Terms and Conditions.
- 1.4. The limited number of the Battery and Merch Pack will be allocated to the first valid claims, while stocks last.
- 1.5. Participants must be resident in Mainland UK a Mainland UK delivery address.
- 1.6. Qualifying Products must be purchased from Qualifying Retailer. For example, purchasers of Qualifying Products from private sellers on eBay (selling products as new or otherwise) and thirdparty sellers on Amazon are not eligible for this promotion.
- 1.7. To make a claim, participants must complete the online registration at <u>paslodeuknordics.ac-page.com/Trim-Redemption-Offer-Sep2025</u>, uploading a copy of their purchase receipt for the Qualifying Product.
- 1.8. Paslode will check the validity of claims on a first come first served basis, until a) while stocks last and b) the Claim Deadline. A valid claim is one which complies with these Terms and Conditions.
- 1.9. Please allow 45 days from the date the claim was submitted to receive the Battery and Merch Pack. Where Paslode is unable to meet this deadline, participants will be informed of the timeframe within which the Battery and Merch Pack is expected to be received.
- 1.10. Those unable to submit their application using the online form due to technical issues should email paslodemarketing@itwcp.com before the Claim Deadline.
- 1.11. Paslode reserves the right to substitute the Battery and Merch Pack with another product of similar value in the event the Battery and Merch Pack is not available. The Battery and Merch Pack is non-exchangeable for another product, non-transferable, and is not redeemable for cash or other products

2. Invalid Claims

- 2.1. Qualifying Purchases purchased after the Claim Deadline will be deemed invalid.
- 2.2. Claims received after the Claim Deadline will be deemed invalid.
- 2.3. Participants must keep the Qualifying Products for a period of at least 30 days from the date of purchase. If the purchased Qualifying Products are returned to Paslode before this date, Paslode will be entitled to claim back the Battery and Merch Pack.
- 2.4. The ONLY Qualifying Products are the IM65 Straight Brad Nailer and IM65A Angled Brad Nailer. Any other tool purchases will not be accepted.
- 2.5. Only one claim per participant and one claim per Qualifying Product purchase is permitted.
