How do we get “\$100 a month”?

Below is an eight-week treatment plan, where the patient receives 0.25 mg per week in the first month (1 mg) and 0.50 mg per week in the second month (2 mg), totaling 3mg of product used. The required medication comes from a single semaglutide 5mg/2ml vial costing \$200, making the monthly treatment cost \$100.

SEMAGLUTIDE TITRATION GUIDELINE

The following guidelines on titration schedule are based on the commercially available products.

First Two Months:

- 0.25mg per week for 4 weeks
- 0.50mg per week for 4 weeks

To follow this schedule, the patient receives the following:

- 1 Semaglutide 5mg/2ml vial
- Syringes
- Alcohol Pads

After the first two months, if the patient has not achieved their goal, then the dosage can be increased as follows:

- 1mg/week for 4 weeks
- 2mg/week for 4 weeks

To follow this schedule, the patient receives the following:

- 1 Semaglutide 12.5mg/2.5ml vial
- Syringes
- Alcohol Pads

After 4 months, next actions are based on clinical outcomes.

TIRZEPATIDE TITRATION GUIDELINE

The following guidelines on titration schedule are based on the commercially available products.

First Two Months:

- 2.5mg per week for 4 weeks
- 5mg per week for 4 weeks

To follow this schedule, the patient receives the following:

- 1 Tirzepatide 30mg/3ml vial
- Syringes
- Alcohol Pads

After the first two months, if the patient has not achieved their goal, then the dosage can be increased as follows:

- 7.5 mg/week for 4 weeks
- 10 mg/week for 4 weeks

To follow this schedule, the patient receives the following:

- 1 Tirzepatide 60mg/3ml vial
- Syringes
- Alcohol Pads

After 4 months, next actions are based on clinical outcomes.

GLP-1 medications are effective for managing A1C levels and weight loss but are:

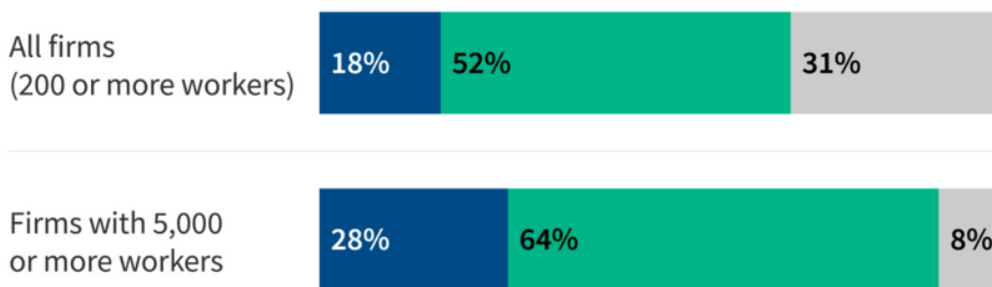
- Very expensive
